<p><b>Multi-currency</b></p> <p>Ability to monitor profit, loss and all other calculations in the currency of your choice; multiple accounts in different currencies; option of switching the account view from one currency to another.</p>

<p><b>Mobile trading</b></p> <p>Platform is available on ALL brands of mobile phones and PDAs around the globe.</p>
<p><b>Trading from the charts</b></p> <p>All orders and trades are displayed on the chart; alter orders right from the chart either by clicking or dragging; open or close a position from within the chart.</p>
<p><b>Quotes Board - large customizable price boxes combined together in one window.</b></p>
<p><b>Pop-up Account windows</b></p> <p>Ability to create a separate Account Details window for every account you trade.</p>

***Integrated news reader***

The platform includes the news reading application connectible to any third party market news provider.

***Client API/SDK***

End user application works over client API what allows trader to use third party tools like MetaStock, Omega Trade Station, eSignal, or custom build tools (e.g. trading robots).

**• For Market Maker / Risk Management**

***Clearing house (STP outsourcing) capabilities***

Platform allows processing of clearing operations with third party financial institutions utilizing their API (Application Programming Interface) and keeps record of outsourced trading within an internal back office.

***Real-time risk management***

Ability for the dealer to manage the company overall exposure. The dealer may view the net exposure of the company in each instrument at any time. The platform monitors not only the customers' positions, but also positions placed by the company at other financial institutions for hedging.

***Real-time exposure by currency for efficient clearing***

***Server side API and FIX support***

Connectivity with the third party platforms using FIX and other standard protocols.

***Automatic Risk Management (ARM)***

Platform automatically generates appropriate orders to the clearing house according to company risk management settings.

***Independent Subsidiary (IS) support***

The Licensee can provide the platform to its Independent Subsidiary company (not an IB) who keeps a corporate clearing account with the Licensee.
